

## 2017 NHFOA Meeting Test 2

On an answer sheet, put T or F for the following questions:

1. K's onside kick attempt is bouncing at the K-47 with K44 and R87 engaged in blocking one another. R initiated the block. The ball touches R87 and is recovered by K62 at the K-49. Ruling. K 1/10 at the K-49. **F. 6-1-5; CB 6.1.5 Situation B.**
2. K 4/7 from the K-37. K3's punt is high in the air and R33 makes a valid fair catch signal on the R-25. The ball tails to teammate receiver R56, who did not signal. He catches the kick and is immediately tackled by K44 at the R-30. Ruling: Kick-catch interference. R 1/10 at the R-30 or re-kick at the K-22. **F. 6-5-3; CB 6.5.3 and comment.**
3. When a punt is used in a free kick after a safety, the kick must be made within one step behind Team K's restraining line. **T. 6-1-2.**
4. A 2/7 at the B-30. A67, a lineman who is in the free-blocking zone, blocks B96, who is also on the defensive line in the free-blocking zone. A67 disengages and then blocks B77 below the waist, who was also lined up in the free-blocking zone. The inside handoff was still in the zone. Ruling: Legal. **T. 2-17-2. CB 2.17.2 Situation B.**
5. A11 comes to the line of scrimmage on a 2/7 play from the B-22. After the team was set for a second, Back A33 goes into motion. While he is in motion, lineman A67, who was in a two-point stance, assumes a three-point stance. After one second the ball is snapped. Ruling: Legal. **F. 7-2-6; 7-2-7; CB 7.2.5 Situation C.**
6. 2/8 from the B-40. A44 and A87 are split to the right side in a spread formation. Both line up on the LOS with A44 covered by A87. At the snap, A44 goes downfield and A87 drops back for a screen pass. A44 catches the ball at the B-37 and runs to the B-28. Ruling: Illegal touching. 3/13 from the B-45. **T. 7-5-13 penalty.**

7. A 3/7 from the B-20. B44 intercepts a pass in the end zone. A43 takes him down with a facemask (twisting and turning). Ruling: B 1/10 at the B-35. **True. 10-4-5.**
8. When a free kick goes out of bounds, the receiving team has the option of penalizing the kicking team from the dead-ball spot. **F. 6-1-8a, b, c.**
9. 2/7 at the B-45. A running play ends close to the B-38, but the Referee determines it is short. Following the Ready for Play, QB A11 asks for a measurement. Ruling: The request should be granted. **F. 5-3-2 Note.**
10. 4/10 at the K40. K3 punts the ball. While R22 and K34 are engaged in blocking downfield at the R-30, K56 legally bats the ball at the R-28 and the batted ball touches R22 in the leg. K45 falls on the ball at the R-25, where it is declared dead. Ruling: Forced touching. R 1/10 at the R-25. **T. 6-2-4. CB. 6.2.4 Situation.**
