

2017 NHFOA Meeting Test 3

On an answer sheet, put T or F for the following questions:

1. A scores on the last timed down of the game to make the score A20, B21. On the successful kick play, B44 roughs the kicker. Ruling: A may choose to re-play the Try after enforcement or penalize B in the overtime period. **T. 8-3-5b. CB 8.3.5 Situation A.**
2. Prior to the game, the Umpire notices the home team's linemen are wearing gloves. He inspects the gloves and finds they have no NOCSAE seal. He tells the coach the gloves must be removed. Ruling: The umpire is correct. **F. 1-5-2b2. Casebook 1.5.2 Situation A, B, C.**
3. 2/7 on the A-20. A44 leads a sweep to the right side and is toward the sideline and outside the free-blocking zone when he contacts B23. He first contacts his hands, which are below his waist, and completes the block at A23's knee at the A-28. Ruling: Illegal block. 2/14 at the A-14. **T. 2-3-7. Casebook 9.3.2 Situation D.**
4. On an on-side kick attempt from the A-40. The ball is topped and rolls toward the 50. K17 blocks R55 at the B-49 before the ball goes 10 yards. Ruling: Illegal block. If accepted, re-kick at the A-30. **T. 9-3-8; Casebook 9.3.8 Situation A.**
5. 2/17 at the A-23. A88 receives a pass from A11 at the A-36 and runs to the A-40, where he is tackled. During the tackle, B77 grasps but does not pull A88's mouthpiece, which was dangling on the facemask. The mouthpiece came out during play. Ruling: A 1/10 at the A-45. **T. 9-4-3b.**
6. A 3/5 at the B-26. Near the end of the third period, A11 advances to the B-18. During the run there is defensive holding on B44. The clock was stopped with 5 second remaining in the first period. Ruling: A 1/G on the B-9. A gets the balance of the 25-second clock even though time expires. **F. 3-3-3; CB 3-3-3 Situation B.**

7. K 4/4 at the K-25. R17 is in position at the R-40 to receive the punt when K44 commits KCI. The official covering the play throws his flag and blows his whistle. Ruling: K 4/4 at the K-25. **F. 4-2-3a and d.**
8. 4/4 on the B-27, A17 runs to the B-24, where he is stopped, and is piled on by B67. Ruling: B 1/10 at the B-12. **T. 5-1-3c, 5-3-1.**
9. K4/17 at the K-40. K3's punt is partially blocked and goes beyond the neutral zone expanded, where it is muffed by B17. The ball rebounds back behind the neutral zone, where it is picked up by K67 at the K-39, who runs to the 50. Ruling: R 1/10 at the K-39. **F. 6-2-3. CB 6-2-3 and Comment.**
10. 2/7 on the B-25. Team A is in a no-huddle offense. QB A12 comes up under center and begins to call signals. He looks over the coverage and steps back (without drawing off an opponent), and calls another set of signals. Ruling: Illegal, false start. **False. 7-1-7a. The quarterback is not restricted once he puts his hands under center unless it simulates the start of a play.**
