

2017 NHFOA Meeting Test 4

On an answer sheet, put T or F for the following questions:

1. 2/13 on the A-5. During the last timed down of the first half, A11 retreats into his own end zone to attempt a pass, but is downed for an apparent safety. During the down, Linebacker B77 is called for defensive holding on Receiver A88 during the play. Ruling: A 2/8 from the A-10, extend the period for an untimed down. **T. 10-5-4. CB 10-5-4 Situation B (b).**
2. A 3/7 from the B45. A11 rolls out to pass and throws to A44, who is open in the end zone. The ball is short and caught by B22 at the 3. His momentum forces him back into the end zone. An inadvertent whistle sounds while B22 is in the end zone. Ruling: Safety or A 3/7 from the B45. **F. 8-5-2a exception.**
3. A 3/14 on the B-40. On a legal forward pass by A11, A88 is held on the B-37 prior to the throw. The pass is complete to back A44, at the B-42 who runs for a score. Ruling: TD. Try on B-1-1/2 or Try on B-3, A kickoff from 50. **T. 10-5-1f; 8-2-2. CB 8-2-2. Situation A.**
4. A 2/7 at the B-30. A67, a lineman who is in the free-blocking zone, blocks B96, who is also on the defensive line in the free-blocking zone. A67 disengages and then blocks B77 below the waist, who was also lined up in the free-blocking zone. The inside handoff was still in the zone. Ruling: Legal. **T. 2-17-2. CB 2.17.2 Situation B.**
5. Third and 7 on the A-45, A86 and A33 come out to the same side with A86 outflanking A33 on the line of scrimmage. A86 is in a 2-point stance, A33 assumes a 3-point stance. On signal both players shift to the other side of the line. Ruling: False start. **T. 7-1-7c; A33 is an "interior lineman" by virtue of A86 "covering" him. If A86 moved first to establish himself off the line, A33 could move because he would be the "end man on the line."**
6. The score is K 24, R 26. On the last play of the game, K attempts a field goal from the R-15, 3/7. Players 48, 24 and 31 line up in the formation between the ends,

with 24 as the snapper. K3 kicks the ball through the uprights. Ruling: Three points for K, game over. **F. 7-2-5, exc. 1; 2-14-1, 2-14, 2a &b.**

7. On a kickoff from K's 40, the ball is muffed by R17 at the R-15 and remains in the air. K44 catches the ball and runs into the end zone. Ruling: TD. Try on B-3. **F. 6-1-5; CB 6.1.5 Situation A.**
8. 2/7 on the B-20. A11 throws a legal forward pass to A33, who is tackled hard by B77 at the B-4. A33 comes up and is flagged for a personal foul on B77 in retaliation for the hit. Ruling: A 1/goal at the B-19. **F. 5-3-1.**
9. On a try from the B-3, A requests the ball be placed on the left hash mark. When the ball is snapped, B44 is called for holding on the pass play attempt, which fails. Following enforcement of the penalty, A may request the ball be placed on the right hash mark. **T. 4-3-6, 4-3-7.**
10. A 3/7 at the A-45. B44 recognizes his team has only 10 players on the field and attempts to get to his team's side of the ball prior to the snap. Before doing so, the ball is snapped. R33 runs for a 9-yard gain. Ruling: Penalize five yards from the end of the run. A 1/10 from the B-41. **F. 3-7-5. CB 3.7.5 Situation B.**
