

2017 NHFOA Meeting Test 5

On an answer sheet, put T or F for the following questions:

1. 2/G from the B-7. QB A11 is contacted following a completed pass to A88, who steps out of bounds at the B-2. The contact causes A11's helmet to come completely off, and was not the result of a foul. Ruling: 3/G at the B-2. A11 must leave the game for one timed down.
2. 3/7 at the A-40. On a long run along the far sideline by A44, tackler B76 grasps the inside front of A44's jersey and pulls forward, taking him out of bounds at the B-20. Ruling: Horse collar. A 1/G at the B-10.
3. Prior to the game, both coaches ask that several balls be approved because of impending wet weather. They ask that should the field become wet the crew change balls up between plays or as necessary. Ruling: The Referee should allow the request.
4. In the last seconds of the first half, Team A is attempting to stop the clock by spiking the ball after gaining a first down at the B-5. QB A11 gets to the line and spikes the snap. He and the center are ready, but none of his players are set at the snap. Ruling: Illegal shift. Start the clock on the Ready.
5. 1/10 at the 50. On a sweep to the right side A44 runs to the B-40 is hit and fumbles. The ball rolls to the B-36, where A22 and B68 attempt to recover it. B68 recovers while his foot is touching the sideline. Ruling: A 1/10 at the B-36.
6. 3/7 from the B45. A11 rolls out to pass and throws to A44, who is covered by B37. B37 interferes with A44, who is able to tip the high pass, which is intercepted by B23. While the ball was loose, the calling official blew and inadvertent whistle before the interception. Ruling: After the play, penalize the DPI. A1/10 from the B-30. Give earplugs to wing on B's side.

7. K's free kick from the K-40 is muffed by R34, who is standing at the R-44 with one foot touching the sidelines. He reaches through the plane of the sidelines to touch the ball. Ruling: Kick out of bounds. R has three options.
8. A 3/6 on the B-26, A32 gets a handoff and runs for a touchdown. During the run, B17 incidentally grabs the facemask of A32. Ruling: Penalty declined by rule.
9. A 1/10 on the B-40. A11 attempts a screen pass to A44, who is positioned at the B-42. The pass is wobbly, and defender B77 comes up and tackles A44, and the pass falls incomplete. Ruling: A 1/10 on the B-30.
10. 2/10 from the B-20. B24 intercepts a legal forward pass on the B-4 and his momentum carries him into the end zone. Prior to entering the end zone, he fumbles on the B-1. The ball rolls into the end zone, where it is recovered by B56. Ruling: B 1/10 at the B-4.
