

2017 NHFOA Meeting Test 8

On an answer sheet, put T or F for the following questions:

1. On a free kick from the K-40, K has three players on the left side of K-3, the kicker, and seven on the right. Following the Ready-for-Play, one player shifts to the left side, and when the ball is kicked, the formation is legal. Ruling: Legal play.
2. With :10 left in the first quarter, A 1/10 at the B-25. A32 gets a handoff is downed at the B-20 inbounds. :06 seconds remain. B94 is called for twisting and turning A32's facemask. The penalty is accepted, the clock starts on the Ready. Ruling: If the clock runs out before the snap, A must be allowed 25 seconds to run the play.
3. In the pre-game conference with the coaches, the umpire notices the visiting team's players have towels on their belts that are the correct size, and are of the same color, but they each have a Nike "swish" on them. He rules they are illegal.
4. 4/goal at the B-7. Receiver A88 runs into the end zone on a pass pattern near the sideline and then buttonhooks. He jumps and receives a pass while in the air and over the goal line. His momentum carries him to the 1-yardline, where he is downed. Ruling. B 1/10 at the B-1.
5. 2/7 on the A-45. On the last play of the first half runner A43 makes a first down, and is tripped up by B93 at the B-45. After being grounded, A43's helmet comes off as a result of the play's action. Ruling: A43 must leave the game for one down to start the second half.
6. 3/7 on the B-9. With 0:04 showing on the clock, in the first period, A11's pass into the end zone is intercepted by B33, who attempts to run it out. During the run, B39 blocks A67 in the back in the end zone. The ball is declared dead on the B-6. Ruling: The penalty is accepted resulting in a safety. The period is not extended for the free kick.

7. During a Try, K13 is the place-kick holder. He receives the snap with one knee on the ground. As K3, the kicker, comes forward, K13 rises with the ball, and runs into the end zone unmolested. Ruling: No points.
8. On an on-side kick attempt from the K-40, the ball fails to go the required 10 yards, where K98 falls on the ball at the K-38. Ruling: Flag K for illegal procedure, re-kick at the K-35.
9. K 4/7 from the K-37. K3's punt is high in the air and R33 makes a valid fair catch signal on the R-25. The ball tails to teammate receiver R56, who did not signal. He catches the kick and is immediately tackled by K44 at the R-30. Ruling: Kick-catch interference. R 1/10 at the R-30 or re-kick at the K-22.
10. A 1/10 at the A-45. Following his preliminary adjustment, snapper A65 removes both hands to confer with his QB. Ruling: Legal play.
