

2018 NHFOA Meeting Test VII

1. A 3/7 from the B45. A11 rolls out to pass and throws to A44, who is open in the end zone. The ball is short and caught by B22 at the 3, who circles back into his end zone (not momentum). An inadvertent whistle sounds while B22 is in the end zone. Ruling: Safety or A 3/7 from the B45.
2. 2/13 on the A-5. During the last timed down of the first half, A11 retreats into his own end zone to attempt a pass, but is downed for an apparent safety. During the down, Linebacker B77 is called for defensive holding on Receiver A88 during the play. Ruling: A 2/8 from the A-10, extend the period for an untimed down.
3. 4/7 from the R-21. K3 comes in for an apparent FG attempt with K12 as the holder on the R-28. At the snap the ball goes high causing K12 to rise in order to secure it. K3 remains in kicking position. K12 returns with his knee on the ground to hold the attempt. Ruling: Legal.
4. 2/7 on the B-20. A11 throws a legal forward pass to A33, who is tackled hard by B77 at the B-4. A33 comes up and is flagged for a personal foul on B77 in retaliation for the hit. Ruling: A 1/goal at the B-19.
5. K 4/7 on the R-20. K3's field goal attempt is partially blocked behind the neutral zone, but deflects beyond the neutral zone and is then muffed by R33. The muffed ball bounces back behind the neutral zone, where K77 picks it up at the R-22, and runs to the R-15. Ruling: Illegal advance. R 1/10 on the R-22.
6. 4/4 on the B-27, A17 runs to the B-24, where he is stopped, and is piled on by B67. Ruling: B 1/10 at the B-12.
7. K's onside kick attempt is bouncing at the K-47 with K44 and R87 engaged in blocking one another. R initiated the block. The ball touches R87 and is recovered by K62 at the K-49. Ruling: K 1/10 at the K-49.

8. Prior to the ready-for-play on a try, A's captain requests the ball be placed at the right hashmark. They go into a spread formation, don't like the defensive coverage and call timeout. After the timeout, A requests the ball be placed at the center Try line. Ruling: Legal.

9. A 2/7 from the B-23. With :20 left in the half, A10 is in a shotgun formation. The snap goes over his head. He recovers the ball at the B-30 and spikes it to stop the clock. Ruling: 3/19 from the B-35. Clock on the Ready.

10. On an on-side kick attempt with :27 seconds remaining in the game. K3 opts to place the ball on the ground, rather than on a tee. After the ready for play, he kicks the ball. Ruling: Illegal kick.
