

2018 NHFOA Meeting Test VIII

On an answer sheet, put T or F for the following questions:

1. On a free kick from the K-40, K has three players on the left side of K-3, the kicker, and seven on the right. Following the Ready-for-Play, one player shifts to the left side, and when the ball is kicked, the formation is legal. Ruling: Legal play.
2. On a free kick from the K-40, K-3 is positioned inside the K-35 along with the rest of K. Following the Ready-for-Play signal he approaches the ball. K56 cuts in front of him and kicks the ball. Ruling: Legal play.
3. A 2/7 on the B-45. QB A12 scrambles to his right and throws a legal forward pass downfield to A88, who runs to the B-12 and is downed. While the pass was in the air, Defender B29 grabs and twists A12's facemask. Ruling: Tack on Roughing the Passer penalty to last completed run. A 1/goal at the B6.
4. 3/7 on the B-40. Defensive back B47 sees receiver A88 running a crossing route while A46 is taking the under route. As they near each other, B47 takes aim at A88 misses him and hits A46 with the crown of his helmet above A46's shoulders. Ruling: Targeting and illegal helmet contact, penalize as one foul.
5. 3/7 from the B-25. Team A's coach calls a time-out to confer with his team and opts for a conference between the nine-yard marks. He brings out a computer tablet. Ruling: If he does not use this to communicate with any player this is legal.
6. 3/8 on the B-40. Airborne receiver A88 catches a legal forward pass near the sideline on the B-25. Defender B54 contacts A88 at the side, and A88 first lands out of bounds. Ruling: Complete Pass.
7. K 4/7 at the K-40. K3's punt is blocked *and stays behind the line*. Personal protector K82 picks up the loose ball and runs to the K-48 where he is downed. Ruling: K 1/10 on the K-48. Clock starts on the Ready-for-Play.

8. 3/7 from the B45. A11 rolls out to pass and throws to A44, who is covered by B37. B37 interferes with A44, who is able to tip the high pass, which is intercepted by B23. While the ball was loose, the calling official blew and inadvertent whistle before the interception. Ruling: After peace is restored, penalize the DPI. A1/10 from the B-30. Give earplugs to wing on B's side.

9. K free kick at the K-40. The ball is sliced toward the sideline, where airborne R-17 catches the ball, then first lands on the sideline on the R-15. Ruling: R 1/10 at the R-15.

10. A 2/7 at the B-30. A67, a lineman who is in the free-blocking zone, blocks B96, who is also on the defensive line in the free-blocking zone. A67 disengages and then blocks B77 below the waist, who was also lined up in the free-blocking zone. The inside handoff was still in the zone. Ruling: Illegal block.
